 - a. Yes, the Letter of Intent to Respond is mandatory and can be submitted as a written letter, mailed or hand delivered to Tim Graham, Purchasing Department, Caddo Parish Public Schools, 1961 Midway Avenue, Shreveport, LA 71108.
- 3) 5.0 Features and Functionality, Table 5.3 Current Parish Handset Models. Are these radios?
 - a. No.
- 4) 5.0 Features and Functionality, Table 5.3 Current Parish Handset Models. What is 4GE, 4GS and VZW?
 - a. This is a device/service type categorization by connectivity service by the existing provider. Further clarification will be provided as it is made available.
- 5) “An eligible response to this RFP will provide a digital cellular service and a wireless Internet Data service on both existing and devices procured through this RFP process to support operational efficiency, emergency operations, Parish communications throughout the Parish and within the Parish facilities. We cannot support service on another carrier device. Does this automatically make our response ineligible?
 - a. No. If an eligible proposer cannot use the current handsets or if the current handsets do not use the proposed network optimally, the proposer should include a recommended device and the associated cost of the device to replace the existing device. Any conversion and provisioning services that are required to change the existing handset should also be listed and any associated cost for the conversion service.
